#### Position Type

Seasonal, part time. Refereeing basketball games for teams in the youth league, grades 3-8. Clinics and training will be held in November-December. Games are held December through February on Saturdays. Scheduling is flexible, but once schedule is made, attendance is required. Scheduled referees are responsible for finding their own replacements. Position is considered a seasonal, at will position.

**Clinic dates for 2017-2018:** Saturday, November 18 and December 2

**Game dates for 2017-2018:** Saturday, December 9-February 24, no games on Dec. 23, 30 and Feb. 17

#### General duties

To provide quality refereeing for the Youth Basketball League. To maintain control of game, coaches and fans. To provide safe environment for players.

**Specific duties** Duties include, but are not limited to:

- Attend all pre season meetings and training
- Actively referee game and maintain control
- Know the Youth Basketball League Rules and Procedures
- Explain violations to players whenever possible
- Handle all coaches concerns and questions
- Demonstrate maturity and responsibility
- Fill in scorebook and operate scoreboard
- Wear assigned uniform (no hats)
- Arrive at work on time and work entire shift
- Secure a substitute if unable to work for any reason
- Additional duties as assigned by Basketball Supervisors
- Additional duties as assigned by Recreation Supervisor

#### Minimum Qualifications:

- At least 15 years old
- Knowledge of game of basketball; preferably plays game on regular basis
- Ability to run around basketball court for entire game
- No referee experience necessary
